**Contest Rules**

1. This contest is open to all residents of Santa Cruz County and the Pajaro Valley Unified School District who are non-professional cooks, both male and female. **ONLY ONE ENTRY PER PERSON IS PERMITTED.**
2. Pies must be prepared and baked at home with fresh apples grown in Santa Cruz County or the Pajaro Valley Unified School District. No other fruit may be added. The pie must be a two-crust pie. **NO lattice top and NO crumb crust may be used. The pie is to be 8" to 10" in diameter.** You may use your favorite pie-baking pan which **MUST BE PICKED UP ON THE DAY OF THE CONTEST.** The fair office storage space is limited; we will not be responsible for your pie dish after this date. PLEASE –NO IDENTIFICATION ON PIE DISH.
3. There will be three (3) divisions:
  - Youth – 17 years of age and under
  - Adult – 18 years of age and over
  - Masters – Anyone who has previously won 1<sup>st</sup> or 2<sup>nd</sup> place in the Adult Division must enter this class.
4. Entry forms are available at the Santa Cruz County Fair Office or the Santa Cruz County Farm Bureau. There is no entry fee. Entry forms must be completed and mailed to the Santa Cruz County Fair Office, 2601 East Lake Ave., Watsonville, CA 95076 on or before Tuesday, September 3, 2013 (postmarked no later than 11:59 p.m., September 3, 2013).
5. The top three pies in each class will be displayed in the Harvest Building during the Fair. **(Remember, all other pies must be picked up immediately after announcement of the winners.)**
6. Prizes in each division will be:                   1<sup>st</sup> -\$45.00, 2<sup>nd</sup> -\$35.00, 3<sup>rd</sup> -\$25.00

**"Best of Show" selected from the top pie in each division - \$45.00**

Contest will be held **Tuesday, September 10, 2013, 12:00 noon at the Paddy Smith Park.** Contestants and guests are welcome with paid admission. Pie dishes may be picked up at the Fair Office after 5:00 p.m.

**Pies are to be brought in 8:00 a.m. to 10:30 a.m. on Tuesday, September 10, 2013 to Paddy Smith Park.**
